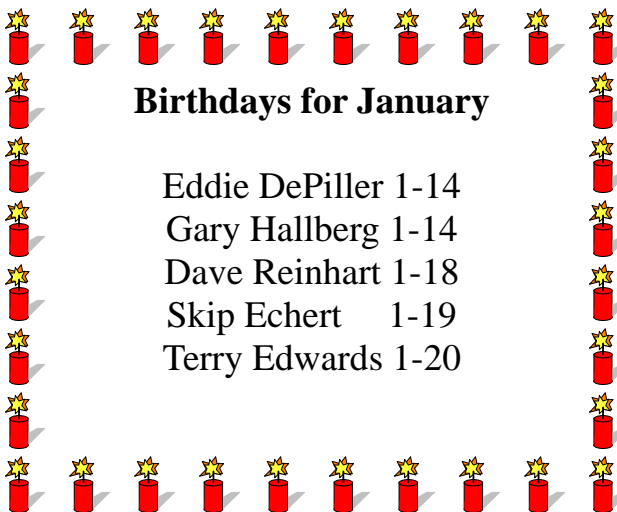
December 2007 PCMC Club Minutes
